### **AGREEMENT TO RULES OF THE CAMP PINEAPPLE**

In order to make this program a success, it is vital that all campers realize that standards of conduct must be understood and observed. Parents/guardians are requested to go over the following items with their child.

I/we agree to observe the following Camp Pineapple Campus Rules:

1. Lanyard with ID must be worn properly at all times.
2. Campers will observe the camp curfew.
3. Campers will be responsible for leaving their apartment and room in the manner in which they found it upon check-in (remove trash, take personal items, etc.)
4. Campers will dress appropriately.
5. Campers must never be alone outside of sessions or residence hall buildings. Unless given permission otherwise, all campers must stay with their assigned buildings/rooms and be supervised by their instructors, camp counselors, resident assistants, or a member of the Camp Pineapple staff.
6. Campers are not allowed to enter personal vehicles or drive vehicles once camp begins until the official end of camp on June 26<sup>th</sup>.
7. Cell phone/electronic devices may only be used during the approved time of day, if necessary. These devices will be turned off at all other times.
8. Respect the personal property of others at the Camp Pineapple.
9. Be respectful of UCF Rosen property and inform a staff member if anything is damaged.
10. Damage to the UCF Rosen College Apartments might result in charges from UCF Housing and Residence Life upon inspection at move-out.
11. Use of tobacco, alcohol, or illegal substances will not be tolerated. Any items found will be confiscated and the participant's parents/legal guardians will be contacted and the participant will be sent home.
12. Possession of firearms or other weapons will not be tolerated. Any items found will be confiscated and the participant's parents/legal guardians will be contacted along with appropriate authorities, and the participant will be sent home.
13. Observe the camp schedule, including session times and other activities.
14. Campers will follow instructions in the lab and only touch equipment and utensils as instructed by chef instructors and assistance.
15. Cooperate with faculty, professionals, teachers, and group leaders at all times.
16. Participate in **all** site tours and activities.
17. Stay safe and always follow directions.
18. Be polite and respectful to everyone. UCF Rosen College and Camp Pineapple do not tolerate bullying of any kind including teasing of counselors and campers. You will be sent home if deemed necessary. We promote diversity and inclusion and want everyone to feel welcome.

**If there is a violation of these Camp Pineapple rules, participants' parents/legal guardians may be contacted to have their participant sent home at their expense, as determined by UCF, at UCF's sole discretion.**
