

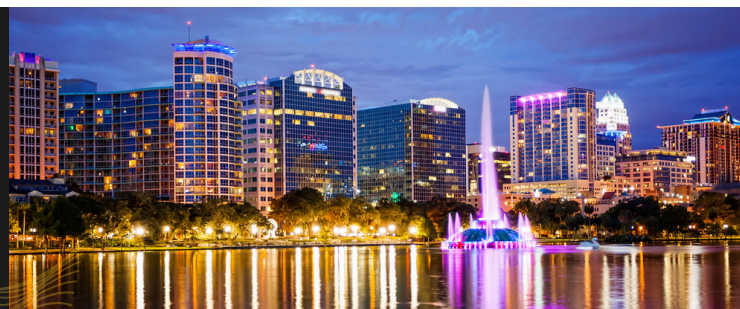

KEY DATES

Abstract submission 15 December 2023
Acceptance notification 5 January 2024
Full paper submission (optional) 8 March 2024

Submissions should be in English and include title, name of the author(s), affiliation, up to 5 keywords and abstract (100 – 500 words) OR extended abstract (up to 2000 words). Authors with accepted submissions can optionally upload the full paper at a later stage.

Authors are not compelled to submit the full paper, but only full papers are eligible for entry into the best paper award. Presentations based only on a submitted abstract may be allocated less time than full paper submissions.

A pre-conference workshop will be organized for PhD students with feedback from established academics on their PhD research projects.

CALL FOR PANELS

The Scientific Committee will evaluate the relevance and quality of the proposals received and will be responsible for the selection of the panels.

Once the selection of the proposals is complete, the information will be updated on the website. The conveners will be informed about the decision of the scientific committee by the organizers.

THE SCIENTIFIC COMMITTEE WELCOME PANEL PROPOSALS ON ANY DISCOURSE, DEBATE, & REFLECTIONS RELATED TO TOURISM ECONOMICS

Panels will be open to accepting papers from conference participants, and the responsibility of selection of papers and inclusivity will lie with the panel conveners.

Only one panel proposal will be accepted per person. At least two of the presenters on the panel must be from different institutions/affiliations.

Panel proposals should include the title and abstract stating the subject and objectives of the proposal, highlighting its academic or practical relevance to tourism economics (maximum 300 words).
